
### **CULTURE AND CREATIVITY AWARD**

#### Dr ANTRI KANIKLI University of York

Dr Antri Kanikli conducts world-leading research that makes a significant contribution to existing knowledge in the area of linguistics and greatly benefits society. Antri's doctoral studies at a leading UK institution provided her with the knowledge, skills and networks required to establish herself as an expert in her field. Antri has a leading role in European and national projects on multilingualism, minority language transmission and language development. Her work on the Erasmus+ project Planting Languages has been awarded with an EPOS quality label by the National Agency in Brussels. Antri holds a PhD in Linguistics.



#### Dr NASIA HADJIGEORGIOU University College London (UCL), University of Cambridge and King's College London

Dr Nasia Hadiigeorgiou is one of the leading human rights experts in Cyprus. In addition to training law students at the University of Central Lancashire, Cyprus (UCLan Cyprus) for more than a decade in the area of human rights issues, Nasia has published a number of reports, academic articles and books on the protection of human rights. Nasia's experience at the three UK universities she attended was fundamental in shaping her belief that a democracy cannot function effectively in the absence of a culture of transparency and a strong civil society. More practically, her own experiences at university convinced her that academics can play a crucial role in developing these crucial components of democracy. Nasia has then taken these lessons and applied them while working as an academic in Cyprus, thus transferring good practices from the UK to Cyprus. Her research has also indirectly shaped and improved human rights practices in Cyprus. Nasia holds an LLB, an LLM and a PhD in Law.








#### PROFESSOR STEPHANIE LAULHE SHAELOU University of Leicester

Professor Stéphanie Laulhé Shaelou is Professor of European Law and Reform, Head of School of Law, Chair of Research and Innovation at the Cyprus campus of the University of Central Lancashire, Cyprus (UCLan Cyprus). For her work on fundamental rights, social justice and citizen empowerment in Cyprus and Europe, she received the European Citizen 2020 Prize from the European Parliament on behalf of the non-profit organisation ICLAIM, which she co-founded and for which she also secured UN observer status on transnational organised crime. For Professor Shaelou, away from more traditional study profiles in Europe, the degree of agility in the British education system remains unequalled, building a legacy for personal and professional development. As Director of the EUfunded Jean Monnet Centre of Excellence for the Rule of Law and European Values CROLEV, Professor Shaelou develops new data on civil society, corruption and transparency for Cyprus/the region to be used in policymaking. Professor Shaelou holds an LLM in European and International Trade Law and a PhD in Law.

#### CHARIS ANGELI University of Dundee

Charis Angeli, a Satellite Controller at Hellas Sat, was named the world's youngest Spacecrafts Controller, redefining the industry. In 2020, he reached the finals of ClimateLaunchpad with a portable wind turbine called Wind-E, designed as a cleantech product intended to revolutionise the charging of electronic devices during outdoor activities. As a Board Member at Together Cyprus and a jury member at Junior Achievement, he actively addresses community and environmental issues. Recognised with the 20 under 35 by SSPI, Charis is a leader driving both technological and societal change. Charis' UK education at the University of Dundee provided a transformative experience, blending technical excellence with a broader perspective, international friendships in a peaceful environment, laying the foundation for him to seamlessly combine business, technology and sustainability. Charis aspires to harness technology and foster purpose-driven international collaborations to craft a future that is not only greener and healthier but also imbued with a touch of joy. Charis holds a BEng in Mechanical Engineering with Renewables.

#### Dr HARIS ACHILLEOS University College London (UCL)

Dr Haris Achilleos is a UK-trained Paediatric Emergency Medicine Doctor and has led the set-up of the first Paediatric Emergency Department in Cyprus.
