Elpidoforos is currently a PhD Candidate in 'Remote Sensing, Geoinformatics and Earth Observation' at the Department of Civil Engineering and Geomatics of the Cyprus University of Technology. He received his Bachelor of Engineering in 2006 from Northumbria University and his Master's in Education (MA) in 2009 from Middlesex University, London. He is the founder of the NGO 'Cyprus Space Foundation' in a bid to educate students in space activities using STEAM. He is an active member of the parliament on research, innovation and digital governance (committee on education and culture). Elpidoforos is the director and founder of the Pascal Space Centre, one of the most advanced educational satellite ground stations in Europe and the project Leader of 'Pascal Mission to Space'. Over the last three years, he has created several Space Science Education and Outreach Activities, including the first Space UP-Cyprus and a national space competition, giving the opportunity to over 2,000 students to participate in different space exploration activities.



## Dr HURI YONTUCU

**Assist. Professor at Eastern Mediterranean University**

Assistant Professor Dr Huri Yontucu is a part-time faculty member at the Eastern Mediterranean University, specialising in peace journalism, media literacy, trauma and contact theory. She has led initiatives on combatting disinformation in collaboration with the Turkish Cypriot Journalists Association and contributed to strengthening media literacy and societal resilience in Cyprus. She received an EU Scholarship for her postdoctoral research at the University of Limerick. She is the author and co-ordinator of *Digital Wisdom Beyond Perceptions*, a trilingual publication funded by the British High Commission. As a peace activist, she has organised bi-communal dialogue programmes fostering mutual understanding and reducing prejudice across divided communities.
